TOURNAMENT RULES

- All USBC rules and regulations apply.
- Handicap is 90% of 210.
- Uses last years (2024-2025) sanctioned league average.
- If no last year average, use current average of 21 games or more at time of bowling. minimum of 21 games. All others bowl scratch
- Management reserves the right to rerate any entry prior to bowling.
- Bowlers are responsible for verifying their own average; average corrections can be made up to the end of the first game of a series, or extended for 48 hours if granted by tournament manager.
- Rules 319c and 319e will apply.
- Prizes pay-off 1 for 4 in team, doubles, and singles all events will pay-off 1 for 8. All prize money will be paid at the end of the tournament.
- Events will consist of 4-member team, doubles, singles, all events, and 300 pot.
- Multiple participation allowed. Team event may be bowled three times by changing two players, doubles bowl twice with change of partners, singles bowl twice cash only once.
- First events bowled count towards all events.
- Reservations close last day and last shift of tournament.
- Management reserves the right to extend tournament if necessary.
- Management reserves the right to refuse any entrant.
- Premature termination of tournament brought about by war, national emergency, or emergency causes thereto or there from, fire, natural disaster, or any reason beyond the control of the NDBPA or South Main Lanes, shall cause, the extent required thereby, all advertised prizes guaranteed or otherwise prorated in accordance with number of entrants who have bowled in each of the respective events up to time of termination.
- All decisions of the tournament manager are final.
- Tournament open to all USBC 2025-2026 certified members, those who are not may purchase an unattached membership card by payment of a \$20 fee. Employees of South Main Lanes are eligible to bowl in tournament.
- Management reserves the right to intermingle shifts. Also in case of machine breakdown, reserve the right to move contestants.
- Added prize money will be divided between entrants.
- Entrants need not report previous winnings.
- All shift times are Mountain Time.
- Prize fund returned 100%.
